TEAMS OR CLUBS ARE RESPONSIBLE FOR COLLECTING EACH ENTRY FEE AND WAIVER FOR PARTICIPATING WRESTLERS AND SHOULD SUBMIT THESE AS A GROUP TO TOURNAMENT DIRECTOR.
