The age of all wrestlers will be determined as of January 1, 2012. The proof of age and insurance is required the day of the tournament and **will be checked.**

Bracketing will be done at random. Weight classes with less than 4 wrestlers will round robin or join the next higher weight class to be determined by the bracketing team.

Collegiate rules will be followed with the following exceptions:

Age groups 4 & under, 6 & under, 7 & 8, 9 & 10 – will wrestle three – 1 minute periods.

Age groups 11 & 12, 13 & 14 will wrestle three – 1 ½ minute periods.

Ties will be broken with a one minute overtime period – wrestlers "on their feet"

(First takedown wins). If tie remains, the first points scored in regulation wins.

All wrestlers will wrestle a minimum of two matches.

We will use 8 man brackets. NO Double Bracketing
