Ages 6 and under: 31,35,39,43,47,51,55,59,HWT
Ages 7 & 8: 45,50,55,60,65,70,75,80,85,HWT
Ages 9 & 10: 55,60,65,70,75,80,85,90,95,100,105,110,HWT
Ages 11 & 12: 65,70,75,80,85,90,95,100,105,110,115,
120,125,130,140,150,HWT

BRACKETING! 8 man brackets will be used. If only one wrestler is entered in a weight class the wrestler will be awarded a medal only and may wrestle in the next weight class. **NO DOUBLE BRACKETING**

RULES: Collegiate rules apply except for the following:

1. Ages 4 through 10 years will wrestle 3 one-minute periods.
2. Ages 11 and 12 will wrestle 3 one and one half minute periods.
3. Ties will be broken with a one minute overtime period with both wrestlers on their feet. The first take down wins. If the tie remains then the first points scored in regulation wins.

AWARDS: 1st place will receive trophies. 2nd, 3rd and 4th will receive medals.

****Wrestlers will wrestle a minimum of two matches.****
