130, 140, 150, HWT

Ages 14 and under: 75, 80, 85, 90, 95, 100, 105, 110, 115, 120, 125, 130, 135, 140, 145,
150, 160, 180, HWT

Ages 16 and under: 106, 113, 120, 126, 132, 145, 152, 160, 170, 182,
195, 220, 285-HWT

BRACKETING: 8 man brackets will be used. If only one wrestler is entered in a weight class the wrestler will be awarded a medal only, and may wrestle in the next weight class. **NO DOUBLE BRACKETING**

RULES: Collegiate rules apply except for the following:

1. Ages 4 through 10 will wrestle 3 one-minute periods
2. Ages 11-12 will wrestle 3 one and half minute periods
3. Ties will be broken with a one minute overtime period with both wrestlers on their feet.

The first take down wins. If the tie remains then the first point scored in regulation wins.

AWARDS: 1ST, 2nd, 3rd, and 4th will receive medals.
