The age for all wrestlers will be their age as of January 1, 2012.

WEIGHT CLASSES:

Age 4 and under: Classes to be set day of tournament
Ages 5 and 6: 30, 35, 39, 43, 47, 52, 55, 59, HWT
Ages 7 and 8: 47, 51, 55, 59, 63, 67, 71, 75, HWT
Ages 9 and 10: 55, 60, 65, 70, 75, 80, 85, 90, 95, 105, HWT
Ages 11 and 12: 65, 70, 75, 80, 85, 90, 95, 100, 110, 120, HWT

Bracketing will be done at random. Weight classes with less than 4 wrestlers will be placed in a round robin bracket or will join next higher class, as determined by the bracketing team.

RULES:

Collegiate rules will be followed with the following exceptions:

1. All age groups will wrestle three one-minute periods.
2. Ties will be broken with a one minute overtime period with wrestlers on their feet
First take down wins. If the time remains, a double overtime period will be wrestled.
All wrestlers will wrestle a minimum of two matches. We will use 8 man brackets.

AND ALL PROCEEDS GO TO THE YUMA WRESTLING PROGRAMS.**

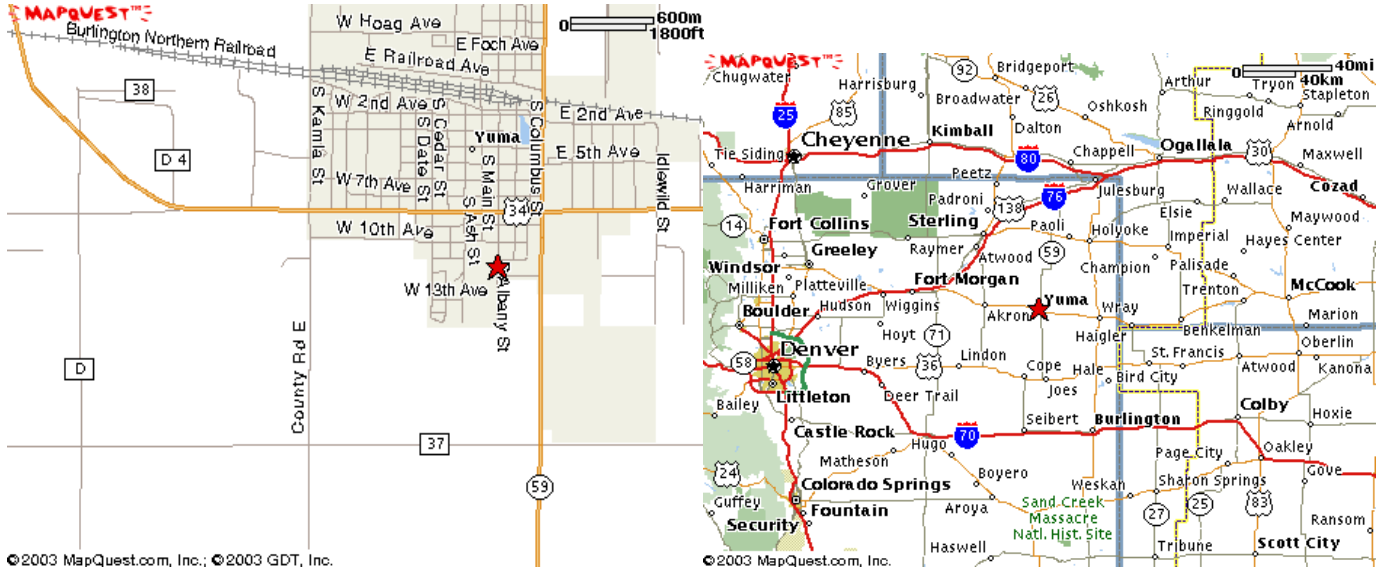
Yuma High School Head coach will be on site to handle disputes and oversee the tournament.
